


Association of Corporate Treasurers of Nigeria (ACTN)

The Association of Corporate Treasurers of Nigeria (ACTN) is the premier professional body representing the interests of corporate treasurers and finance professionals in Nigeria. Our mission is to empower treasury and finance professionals through advocacy, knowledge-sharing, professional development, and networking opportunities.

Founded to address the evolving challenges of corporate treasury management, ACTN provides a robust platform for professionals to enhance their expertise, stay ahead of industry trends, and contribute to Nigeria's economic growth.



Activities

ACTN seeks to collaborate with the government and other regulatory bodies in formulating applicable policies, establish funds for the maintenance and promotion of research into key areas of corporate treasury, and to encourage and establish dialogue among treasury, risk management and corporate finance practitioners through periodic journals, regular workshops and presentations on relevant subjects. Its activities include:

- 1. Advocacy: We spearhead advocacy for change in both the professional ethos of the function as well as in the fostering of the use of technology to drive the Corporate Treasury Function. A key element of our advocacy involves partnering with Regulatory bodies to give insights on the possible impact of policies that are under consideration, from a Corporate perspective.
 - Meetings: We host regular meetings on a range of topics, from discussions on issues of professional development, alternative and non-conventional mode of funding available to corporates, foreign exchange policy and structural imbalances, issues relevant to the development of the corporate treasury function (as distinct from the interbank treasury function), meetings to review the economic outlook and/or the performance of the economy, and


